The vehicle will be available for inspection between 2:00pm. to 4:00pm on 14th and 16th June 2017.

The quotations will be opened in the Room of Under Secretary, Room No.434, C Wing, Shastri Bhawan, New Delhi. The bidders or their representatives (not more than one for each quotation) may be present, if they so desire, at the time of opening of Quotations.

The sale will be governed by the following conditions:-

- I. The bidders are required to pay Earnest Money of Rs. 5,000.00 (Rupees five Thousand only) for the Vehicle.
- II. Earnest Money is payable by means of Demand Draft drawn in favour of PAO, Deptt. of Chemicals & Petrochemicals, New Delhi. (payment by cheque or cash shall not be accepted)
- III. Quotations received without demand draft towards Earnest Money will not be considered and shall not be accepted.
- IV. The successful bidder will be required to deposit the bid amount by mean of Demand Draft drawn in favour of PAO, Deptt . Chemicals & Petrochemicals New Delhi within two working days of the acceptance of the bid.
- V. The Earnest Money of the successful bidder will be released only after he deposits the sale proceeds. Earnest Money will not be adjusted as sale proceeds and will be forfeited if he fails to honour the bid.
- VI. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Voter Identity Card in case of individual and Registration Certificate in case of firms etc.)
- VII. The sold vehicle will be removed by the successful bidder within 48 hrs. of depositing the money, at their own expenses.
- VIII. The vehicle will be disposed of on "as is where is basis "and no guarantee for its worthiness or quality will be given by the Deptt..
- IX. The successful bidder will also be responsible for getting the Registration Certificate of the Vehicle transferred in his name at his own cost expeditiously. The office will not be responsible for any lapse on his part in this regard.
- X. The bidders will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
