

Subject: Industry Facilitation Cell at Department of Chemicals & Petrochemicals-reg.

 - iii. To follow up with relevant Divisions of DCPC on the issues raised
 - iv. To assist the industry in Research and Development in the sector through various schemes/ Technology Development Board etc.
4. The Industry Facilitation Cell will initially set apart a time from 4.00PM to 6.00 PM every Thursday where the industry members can come and articulate their issues.
5. Proper records will be maintained by the IFC to ensure institutional memory and follow up with concerned.
