Monthly Summary for the month of January, 2018

Important events for the month of January, 2018 are as follows:

1. During the month, Brahmaputra Cracker & Polymer Limited (BCPL) has produced 20,002 MT of Polymer and 3,830 MT of Liquid Hydrocarbon. 17,374 MT of Polymer and 3,717 MT of Liquid Hydrocarbon have been sold during the month.
2. As on 31.01.2018, Central Institute of Plastics Engineering and Technology (CIPET) has trained 35,058 persons (13,843 through long term training programmes and 21,215 through short term training programme) under its Skill Development Schemes.
3. Secretary (C&PC) chaired the first meeting of Joint Committee set up to recommend a broad policy and perspective plan for Petrochemical Sector in the country, on 04.01.2018. In the first step the Committee directed Indian Oil Corporation Ltd. (IOCL) to undertake assessment of demand-supply scenario of petrochemicals for next 15-20 years, in consultation with industry and other stakeholders.
4. In the month of January, 2018, 29 public grievances were brought forward and 20 grievances were received, of which 38 have been disposed of. Of the remaining 11 grievances, only 01 is of more than 90 days pendency.
5. The department observed Martyrs' Day on 30th January in the memory of those who gave their lives in the struggle for India's freedom by observing 2 minute silence.
