APPOINTMENT OF CONSULTANT

It is proposed to engage technical consultant in this Department on following terms & Conditions:-

(i) Minimum Educational Qualifications:-

Master's Degree in any branch of Chemistry (but excluding Bio-Chemistry) from a recognized University.

OR

Degree in Chemicals Engineering/ Chemicals Technology from a recognized University/Institute. .

(ii) Experience:-

Retired officers under the Central/State Governments/Union Territories/Semi Government Organizations/Statutory bodies/universities/Public Sector Undertakings/Autonomous bodies/ Research Institutions recognized by Government, fulfilling the following conditions:-

(a) Retired at least at the level of Deputy Secretary to the Government of India or equivalent with minimum five years experience in Chemical/Petrochemical sector.

OR

(b) Retired at least from E-4 level or equivalent from Central/State PSUs with minimum five years' working experience in Chemical/Petrochemical sector.

(iii) Persons from private sector may also apply provided they fulfill the minimum educational qualifications stated in Sl. No. (i) above and have minimum of five years working experience in Chemicals/Petrochemicals industry.

(iv) The consultants proposed for engagement shall be well acquainted with the functioning of Central government Ministries/Departments.

(v) The engagement shall be initially for a period of five months or whenever regular incumbents are available whichever is earlier.


(vi) Working hours shall normally be from 09:00 AM to 5:30PM during working days including half an hour lunch break in between. However, in exigencies of work, he/she may be required to sit late and he may be called on Saturday/Sunday and other Gazetted Holidays.

(vii) Consultants shall be eligible for 04 days leave during the period of six month. However, unavailed leave cannot be carried forward, in case of extension beyond six months.

(viii) The engagement may be terminated at any time by the Government without assigning any reason by giving a notice of fifteen days. The engaged consultant also reserves his/her right of termination of Contract of engagement by giving the Department one month's notice in writing or payment of remuneration of one month i.e. Rs. 50,000/- (Rupees Fifty thousand only) consolidated.

(ix) The consolidated consultancy fee would be Rs 50,000/- (Rupees Fifty thousand only) consolidated per month. No other allowance is admissible.

TERMS OF REFERENCE

Issues relating to International Conventions

1. To oversee implementation of Chemical Weapon Convention (CWC) firming up India's stand for various issues for meetings of executive Council and Conference of State.
2. Examination of newer industry cluster issues raised from time-to-time under CWC.
3. Submission of Annual Declarations for Anticipated Activities (ADAA) and Annual Declarations for Past Activities (ADPA) to National Authority, CWC.
4. Examination of references received from MoEF on future candidates for inclusion in Rotterdam Convention on Prior Informed Consent Procedures (PIC) and acknowledging notifications received from exporting country under Article 12 of the Convention – as DNA for industrial chemicals.
5. Formulation of EXIM Policy for industrial chemicals included in Annexure III of Rotterdam Convention.
6. Examination of references received from MoEF on future candidates for inclusion in Stockholm Convention on Persistent Organic Pollutants.
7. Examination of various issues on REACH legislation and to prepare our industry to be REACH compliant.
8. Examination of references received from MoEF under Montreal Protocol on phasing out of ODS.
9. To associate with MoEF for host country approval of CDM projects under Kyoto Protocol in the Chemical Sector.
