MONTHLY SUMMARY FOR THE MONTH OF AUGUST, 2018.

Important events for the month of AUGUST, 2018 are as follows:

1. During the month, Brahmaputra Cracker & Polymer Limited (BCPL) has produced 25,399 MT of Polymers and 4,764 MT of Liquid Hydrocarbons. 32,804 MT of Polymers and 5,025 MT of Liquid Hydrocarbons have been sold.
2. Secretary (C&PC) Chaired the 14th meeting of the Scheme Steering Committee (SSC) with officials of GIDC on 02.08.2018 to consider the preliminary proposal received for setting up a Plastic Park in Narigam Village, Bhavnagar, Gujarat. He also Chaired 15th meeting of the Committee on 17.08.2018 to discuss the status of compliance of the Plastic Park project at Bilaua.
3. During the month of August, 2018, 18696 students completed their skill training through long term/ short term training programmes at different centres of CIPET under its skill development schemes.
4. Secretary (C&PC) held meetings with officials of Andhra Pradesh Industrial Infrastructure Corporation (APIIC), Visakhapatnam Urban Development Authority, GAIL and others at Vishakhapatnam on 13.08.2018 to review the progress of CIPET centre at Visakhapatnam and to monitor the implementation of Andhra Pradesh PCPIR.
5. Secretary (C&PC) also co-chaired a meeting of the Committee on Petrochemical Perspective Plan along with Secretary, Ministry of Petroleum & Natural Gas on 27.08.2018.
6. Till August, 2018, the Office of Welfare Commissioner for Bhopal Gas victims has decided 60,146 ex-gratia cases, out of which 48,669 cases were awarded and 11,477 were rejected. An amount of Rs. 813.52 crore has been awarded to 48,669 claimants. During the month of August, 2018, an amount of Rs. 2.24 crore has been disbursed in 137 awarded cases.

- 7 A meeting/video conference held on 08.08.2018 under the Chairmanship of Secretary (C&PC) to review the preparation of the Department and organisations under its administrative control for the activities to be undertaken during Swachhta Pakhwada of the department to be observed during 1st - 15th September, 2018. Necessary instructions were issued to all concerned to ensure that Swachhta activities are undertaken in an effective manner.
- 8 The Department launched 2 activities on the MyGov portal in observance of its Swachhta Pakhwada viz:
- i) A Slogan Writing Competition on "Bringing out the positive role of Plastics and removing the negativity around use of plastics" launched on the MyGov Portal to run for 5 weeks from 27.07.2018 to 31.08.2018.
- ii) A Paragraph Writing Competition on "Success Stories: Positive impact of plastics in the daily life of citizens" launched on the MyGov Portal to run for 5 weeks from 27.07.2018 to 31.08.2018.
- 9 Sadbhawana Pledge was taken by the officers/ officials of the Department on 20.08.2018 to commemorate the birth anniversary of ex- Prime Minister Late Rajiv Gandhi.
- 10 Senior Economic Advisor, who also oversees the Rajbhasha related work, represented the Department in the 11th "Vishwa Hindi Sammelan" held in Mauritius from 18th to 20th August, 2018.
- 11 A Hindi Karyashala was organised in the Department on 21.08.2018 in which a total of 21 officers/officials participated.
- 12 In the month of August, 2018, 11 grievances were brought forward and 37 grievances were received, of which 44 have been disposed of. Of the remaining 4 grievances, no grievance is of more than 90 days pendency.
